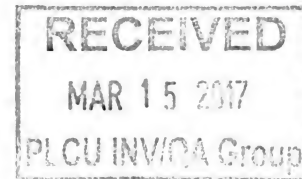

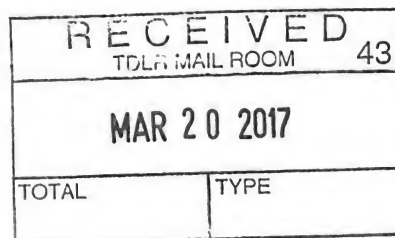

Subject: Report on Midwife Complaint

The City of Laredo Health Department responded to a citizen complaint that Mr. Ruben Casillas, a registered midwife with the State of Texas was operating an inappropriate facility and as a result the person feels her birth outcome may have been adversely affected .

An inspection was made on February 10, 2017, by our staff at 2018 Hidalgo Street. Mr. Casillas is the midwife for the clinic and Ms. Gallegos is the administrator/medical assistant. Mr. Casillas was not present during the inspection. He has a Texas Midwifery license number 98003, with the initial date of 1993. Only natural births are performed at the clinic, there are two (02) dry delivery rooms and one (01) wet delivery room and one (01) examination room. The inside of the clinic appeared in good sanitation conditions at the time of inspection. The outside had an old mattress and other debris in the back of the building (photographs attached). Ms. Gallegos was advised to clean up the back area of the building and to start using the proper disinfectants for the delivery rooms and examination room.

The complainant shared a lengthy concern of her medical outcomes and believes she had an adverse outcome. Upon our assessment and other complaints in the past we are monitoring the clinic but as well are sharing this with you. Upon your request we can provide the information of the complainant.
